#### **Population Genomics & Precision Prescribing in Community Care**

Precision prescribing and pharmacogenomics have a key role to play in optimizing and improving patient outcomes in community care, but ensuring scalability and seamless integration is critical to its implementation. Dr. Akwasi Asabere, population genomics expert and Senior Director, Service Line Strategy at Helix shares his insights on how we can utilize population genomics to overcome current barriers and provide actionable pharmacogenomic results as standard of care.

#### **Barriers to Implementing Precision Medicine at Scale**

Precision medicine was poised to transform clinical practice in 2003 when the Human Genome Project reached completion but resistance to implementation exists in today's healthcare sys-

tems. In this session Stephen Sammut will discuss the barriers to the diffusion of precision, personalized care and what needs to be done to reach diverse and underserved populations.

#### Pharmacogenetics at the Population Level

Pharmacogenetics (PGx) is an emerging science that evaluates the effect of various so-called pharmacogenes on the safety, tolerability, metabolism and efficacy of individual drugs at the individual patient level. PGx is cost effective when used judiciously. We have utilized the logic of a clinical decision support tool to evaluate drug-drug interactions for a large number of individuals. Knowing the distribution of pharmacogenetic variants in the general population, we then use proprietary logic to impute genetic risk using a modified Monte Carlo simulation algorithm. In this way we are able to stratify a population according to risk, and conduct assays on those at highest risk of a major drug-drug-gene interaction.

#### Leveraging Machine Learning and Medical Claims Data to Predict Future High-Cost, High Need Patients

A small number of people contribute disproportionately to the overall healthcare costs of the population. Those individuals' healthcare needs are mostly unmet, and many receive unnecessary and ineffective care. Predicting those members who may become high-cost, high-need early on can lessen the burden on healthcare providers and insurers, while providing opportunities for early interventions, which have the potential to drive improved patient outcomes. Health Advocate has developed a machine learning approach to predicting high-cost, high-need patients from medical claims data. This approach identifies opportunities to intervene before patients, providers, and insurers incur higher costs, effectively addressing gaps in care and improving patient outcomes.

## Using Payer and EMR Data to Connect Business Strategy and Operational Outcomes

Many Americans who depend on employer-sponsored health care are managing complex, costly health conditions and face significant gaps in diagnosis and disease management across race, ethnicity and income levels, according to a recent analysis from Morgan Health (a JPMorgan Chase & Co. business unit) and NORC at the University of Chicago. Despite perceptions around the robustness of coverage within employer-sponsored insurance, enrollees experience significant barriers to accessing care, particularly for those of racial/ethnic minority backgrounds and individuals with low or modest incomes.
